Andrés RODRÍGUEZ-POSE

Andrés Rodríguez-Pose is Professor at London School of Economics Department of Geography and Environment. Andrés Rodríguez-Pose is the immediate Past President of the Regional Science Association International (2015–2017). He served as Vice-President of the RSAI in 2014 and has also been Vice-President (2012–2013) and Secretary (2001–2005) of the European Regional Science Association. He is an editor of Economic Geography and sits on the editorial board of other scholarly journals, including many of the leading international journals in economic geography, human geography, regional science, and management.



Alessandra FAGGIAN

Alessandra Faggian is Professor of Applied Economics, Director of Social Sciences and Vice Provost for Research at the Gran Sasso Science Institute, L'Aquila, Italy. She is current co-editor of Journal of Regional Science and previous editor of the journal Papers in Regional Science. Alessandra Faggian is the 2007 recipient of the Moss Madden Memorial Medal by the RSAI Irish and British section and the 2015 recipient of the Geoffrey Hewings Award by The North American Regional Council. In a recent ranking of the top 100 regional scientists in the world (Rickman and Winters, 2016), she was ranked 19th.

André Torre is the Head of Maison des Sciences de l'Homme at University Paris-Saclay and Research Director at the INRA (National Institute for Agronomic Research). He serves as the Managing Editor of Revue d'Economie Régionale et Urbaine. He was the President of French Speaking Association of Regional Science (ASRDLF) between 2008 and 2011. From 2014 to 2018 he was the Vice President of ERSA and its representative at the RSAI Council. He is the President of the European Regional Science Association (ERSA) since 2019.


